DBA EVENTS

- Winter Promo
 - Winter Promo is a yearly collaborative marketing effort to promote all holiday activations that DBA members plan on having during the holiday season. DBA will collaborate on radio ads, flyers, and print promotion.
- Gallery Walk
 - Gallery Walk takes place on the First Friday of December. Historically, DBA coordinates the closing of Front Street in downtown to allow for mingling and entertainment in the street. In 2015, Front Street was packed with residents from downtown, Douglas and the Valley, all enjoying the entertainment coordinated by DBA.
- Candidate Forums
 - The Downtown Business Association will host mayoral candidate forums that focus on downtown topics.
- Downtown Swagger
 - The DBA coordinated a Downtown Swagger for downtown businesses and its employees so that employees can become familiar with other businesses and their plans for the summer. The Swagger was a huge success, bringing out more than 100 participants.

Doing Business Downtown

- Garbage
 - Garbage cans may be put out to the curb for collection no sooner than 4 a.m. on pickup day.
 - Other than after 4 a.m. on pickup day, garbage must be kept in a bear resistant container or enclosure.
 - in a strong fully enclosed structure such as a garage
 - in another "bear resistant enclosure," defined as an enclosure that you can't get into unless you use hands or tools. If it can be opened by stomping on it, kicking it, running into it with your body, or other similar action, it is not bear resistant.
 - If your garbage has attracted bears and you fail to take steps to legally store your garbage, you could be cited for maintaining a bear attraction nuisance, a \$50 fine for the first offense.
