



#### **Today's Business:**

• Midgi Moore to give update on Norwegian delegation visit

RECAP in Midgi's words: The Norwegian delegation was made of cruise industry leaders, municipal
leaders, and business development managers who are located in Norwegian coastal cities. These cities



were cruise ports similar to Juneau and Skagway and the purpose for their visit was to learn more about how we as cities and business leaders work with the cruise industry.

There was much discussion regarding environmental issues, water, and economic issues. Each delegate introduced him/herself and then the Juneau leaders did as well. Juneau's Mayor, Deputy Mayor and City Manager were present. As were Kirby Day from Princess, representatives from the state and from the forest service.

She spoke of the resiliency of the downtown corridor, how the DBA is looking for opportunities to grow activities during the "off" season and how we work together with the city to better our downtown area. When asked about the shuttered businesses during winter, she addressed that although we do have some seasonal businesses, the majority of our businesses (north of Red Dog Saloon) was open year-round and that we have events such as Gallery Walk to encourage locals to head downtown. She also mentioned that we have Eagle Crest, a rich music and artistic culture, and that Travel Juneau encourages visitors to come to Juneau all year. The delegates were very interested in knowing more about off season and how to engage local businesses more in the cruise industry.

### • Update on Main Street presentation

Jill told everyone about how Terrie Latsky wanted to donate money for the consultant that we choose to hire.

Evelyn suggests that we reach out to downtown businesses and see if they would be willing to pay for a third of a cost of the Main Street implementer, for the City to pay a third of the cost and for DBA to pay for a third of the cost.

The Board agreed to read the proposal in the next day or so and move forward with an email vote.

ACTION – Dana to send the proposal and the presentation to the Board so we can make a decision. Evelyn will set up the budget for Main Street.


Board suggestions –



Nathaniel walks through the Pat Race proposal. Midgi asks the board about the purpose of the map – is it a way finding tool or an art tool? Do we want people to take it because it's cool or because it's a tool? Sydney mentions that this has been talked about at the marketing committee in great detail – the concept is to position Downtown Juneau as a unique + quirky place. Part of our identity as downtown Juneau is this homegrown, quirky look and this map represents that. We are trying to market downtown as an excursion. Eric brings up a couple concerns – if DBA is paying for this then it needs to be representative of ALL DBA businesses – including the seasonal businesses. Sydney – we have to be aware of his proposal for editing. Evelyn – she has experience with this sort of proposal. Arts have editorial control but the board still has the right to veto content. Eric – we need to be very hands on in the first go around and make sure that people are aware of how they are getting represented.

ACTION -- Nathaniel will talk to Pat and hammer out all the concerns in regards to editorial and the way it's framed. And letting him know the Board will have final say.
